### SECTION III: CWA ANALYSIS

#### A. TNWs AND WETLANDS ADJACENT TO TNWs

The agencies will assert jurisdiction over TNWs and wetlands adjacent to TNWs. The palustrine wetlands within the waterfilled depression labelled as PUB-2 (4.15 acres) drain to Oso Creek by a 460-foot-long drainage ditch excavated from uplands that is normally dry.

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

The RA contains palustrine wetlands that have developed in water-filled depressions created in dry land incidental to construction activities, as defined in the 33 CFR Part 320 preamble (1986). These depressions (wetlands PUB-1, PUB-3 and PUB-4) do not have any naturally occurring surface water channel that contributes surface water flow to a territorial sea or traditional navigable water in a typical year, either directly or indirectly through other tributaries, jurisdictional lakes, ponds, or impoundments, or adjacent wetlands.

The palustrine emergent wetlands that have developed in the water-filled depression labelled as PUB-2 does contribute flow to Oso Creek by way of a drainage ditch excavated from uplands; therefore, it is considered jurisdictional subject to Section 404 of the Clean Water Act. The ditch itself is best defined in the preamble as a non-tidal drainage and irrigation ditch excavated on dry land and serves to provide a path of conveyance from PUB-2 to Oso Creek.

The southern portion of the review area does abut a traditional navigable water (Oso Creek), of which 12.92 acres are subject to the daily tide, and therefore, subject to Section 10 of the Rivers and Harbors Act of 1899 and Section 404 of the Clean Water Act. In addition, approximately 2.92 acres of estuarine fringe wetlands adjacent to Oso Creek (Wetland EST-1) are within the review area that are subject to Section 404 of the Clean Water Act.
