Explain: **DT-1 (2285 LF, 0.09 acres) and DT-2 (1562 LF, 0.18 acres) are man-made agricultural drainage ditches with relatively non-permanent flow that does not exhibit a direct hydrologic connection to a WOTUS and appeared to have been constructed wholly in uplands and drain only in uplands. These resources are not regulated pursuant to the 1986 preamble and does not meet any definitions under 33 CFR 328.3. They include erosional features (gullies and rills), and swales and ditches that are not tributaries or wetlands.**

S-1 (49 LF) and S-2 (1980 LF): Unvegetated swale features did not extend the OHWM of a WOTUS and were characterized as agricultural irrigation ditches within an active turf farm. These resources are not regulated pursuant to the 1986 preamble and does not meet any regulatory definition under 33 CFR 328.3. They include erosional features (gullies and rills), and swales and ditches that are not tributaries or wetlands .

Emergent wetland features EW-1 through EW-6 (0.10 acres) were observed within low-lying man-made agricultural irrigation ditches and located outside of the 100-year floodplain for Q100-00-00 (Cedar Bayou). Feature EW-7 (0.03 acres) was also located outside of the 100-year floodplain for Q100-00-00 (Cedar Bayou). These resources are not regulated pursuant to the 1986 preamble and does not meet any regulatory definitions under 33 CFR 328.3. They include artificially irrigated areas which would revert to upland if the irrigation ceased.

The two open water features, OW-1 (0.20 acres) and OW-2 (3.23 acres), within the study area are man-made ponds, excavated in upland areas that do not contribute surface hydrologic connection to a WOTUS and are located outside of the 100 -year floodplain of Q100-00-00 (Cedar Bayou). These resources are not regulated pursuant to the 1986 preamble and does not meet any regulatory definitions under 33 CFR 328.3. They include artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing..

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
