Based on the Federal Emergency Management Agency (FEMA) Flood Insurance Rate Map (FIRM), there appear to be no discrete or confined surface hydrological connections between the subject wetland and any water of the U.S. The exact boundary (as standard with isolated wetlands) was not verified, but the feature polygon was examined via aerial photography to ensure that it is an enclosed polygon surrounded by uplands. The nearest water of the United States is Dry Creek, approximately 1,410 feet northeast of the wetland, and a Tributary to the Brazos River, a Traditional Navigable Water.

The subject wetland is located outside of the 100-year floodplain of any water of the U.S., including Dry Creek.

The subject wetland is neither currently used, nor was used in the past, nor is susceptible to use for interstate or foreign commerce.

The subject wetland is not subject to the ebb and flow of the daily tide.

The subject wetland does not cross interstate or tribal boundaries.

There are no indications that this "Isolated*" wetland would 1) affect or be used by any interstate or foreign travelers for recreational or other purposes, 2) affect or be used for fish or shellfish that could be taken and sold in interstate or foreign commerce, or 3) be involved in any direct current use or potential use for industrial purposes by industries in interstate commerce.

The subject wetland is not an impoundment of any water of the U.S.

The subject wetland is not part of a surface tributary system to any water body.

The subject wetland is not part of the territorial seas.

The subject wetland is not prior converted cropland.

The subject wetland is not located "Adjacent**" to waters of the U.S. (other than waters that are themselves wetlands).

The subject wetland is not located reasonably close to a waters of the US as to infer they are "ecologically adjacent"; for a water/wetland to be determined to "reasonably close" it must be in a geomorphic position such that an ecologic interconnectivity is beyond speculation or insubstantial for a known biologic species that requires both, the subject waters/wetlands and the nearest known waterbody (a known water of the U.S. other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

There are no known species in this geo-region that requires both these waters/wetlands under review and the nearest known waterway to fulfill their life cycle requirements, therefore these waters/wetlands are ecologically isolated. The wetland does not have a known nexus to interstate commerce. Therefore, it is the Galveston District draft opinion that the wetland is isolated and not subject to Section 404 of the Clean Water Act (Section 404) or Section 10 of the Rivers and Harbors Act (Section 10).

Additionally, the tract contains 2 upland manmade ditches (Ditch 1 = 740 linear feet and Ditch 2 = 1,000 linear feet). The ditches were constructed out of uplands, drain only uplands, do not re-route a water of the United States, and do not extend the ordinary high water mark of a water of the United States. Therefore, Ditch 1 and Ditch 2 are not waters of the United States and are not subject to Section 404 or Section 10..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: As described in the attached Delineation Report prepared by Berg Oliver Associates, Inc, dated January 15, 2020, four aquatic features were identified within the 80-acre property and project area footprint. The property review area was modified to only include the lower portion of the property, approximately 50-acres, and thus only one aquatic resource under review, as indicated in the EPA coordination maps. The remaining aquatic resource is a small wetland that appears to have been created in 2015 when the detention area and ditches were constructed. Although the aquatic feature appear to be isolated from downstream navigable waters by a lack of surface hydrologic connection, a significant nexus test is not required because the waters are excluded from the definition of waters of the U.S. (WOTUS) in the preamble of the 1986 Federal Register defining WOTUS.
