Explain: **Wetland Areas, Wetland A, B and C (0.61 acres total - See Table 1 Attached for individual acreages) were determined to be isolated. These areas did not exhibit an established OHWM, but**

generally did meet all three wetland criteria. These areas likely retain water after rain events, but did not demonstrate a direct hydrological connection to any potentially jurisdictional water features. All three areas, Wetlands A, B and C were separated by an elevated herbaceous uplands or wooded uplands ridge e. approximately 2.0 to 2.5 feet higher in elevation. Wetland A does not appear to drain to any direction and pools

water after precipitation events until the area dries by evaporation. Wetlands B and C appear to be caused by abandoned (failed to develop subdivision), unmaintained old road side ditches that flow over onto bordering land and pools water after precipitation events until the area dries by evaporation. These areas are several feet above the OHWM of Water 1 (above noted). Since these areas have no flow events, demonstrate no connection to other potentially jurisdictional features, and are related to man-made features constructed through uplands, they would not be considered jurisdictional. Areas A, B & C are NOT waters of the United States (U.S.) as defined in 33 CFR 328.3 (a). (1) These areas are not currently used, or was used in the past, nor is susceptible to use interstate or foreign commerce. These areas are not subject to the ebb and flow of the daily tide. (2) All three areas do not cross interstate or tribal boundaries. (3) the destruction of these areas could not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce. (4) These areas are not impoundments of waters of the United States. (5) These areas are not part of a surface tributary system of (a) (1) through (4). (6) These areas are not part of the territorial seas. (7) These areas are not adjacent to waters (other than waters that themselves are wetlands) identified in (a) (1) to (6).

These areas have been determined by the Galveston District to NOT be adjacent, (bordering, contiguous, or neighboring) as defined by 33CFR 328.3.(c) Areas A, B and C are located out of any 100 -year floodplain of any water of the U.S. and do not have confined hydrological surface connection to any water of the U.S. These areas are isolated waters as defined in 33 CFR 330.2 (e) as: Isolated waters mean those non-tidal waters of the United States that are: (1) not part of a surface tributary system to interstate or navigable waters of the U.S.; and (2) not adjacent to such tributary waterbodies. Areas A, B and C are NOT waters of the U.S.

The wetlands were identified using the 1987 Manual and 2010 Regional Supplement: Atlantic and Gulf Coastal Plain Region (Version 2.0), which requires that all three wetland criteria be present under normal circumstances for an area to be determined a wetland. The wetlands are located in depressional areas that experience seasonal hydrology during and after rain events, providing the conditions necessary for wetlands to establish.

The subject wetland is not located reasonably close to a water of the US as to infer it is "ecologically adjacent"; for a water/wetland to be determined to "reasonably close" it must be in a geomorphic position such that an ecologic interconnectivity is beyond speculation or insubstantial for a known biologic species that requires both, the subject water/wetland and the nearest known water of the U.S. other than an adjacent wetland to fulfill spawning and/or life cycle requirements. There are no known species in this geo-region that require both this water/wetland under review and the nearest known waterway to fulfill their life cycle requirements, therefore this wetland is ecologically isolated. The wetland has no known nexus to interstate commerce. Therefore, it is SWG position that Wetland (A, B and C) is not a Water of the U.S. and is not subject to Section 404 of the Clean Water Act or Section 10 of the Rivers and Harbors Act.

Water 1 (HCFCD G103-15-00) is an upland stormwater ditch that is not located below the OHWM of Lake Houston and does not replace a tributary of the United States nor meets the definition of a tributary pursuant to 33CFR 328. Therefore, this upland drainage ditch is not subject to Section 404 of the Clean Water Act.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
