contains 1 wetland of approximately 5.25 acres. There is 1 man-made ditch totaling approximately 431 linear feet that was partially constructed within the wetlands. The ditch connects to a culvert that goes under the road. There is a feature on the other side of the culvert on the neighboring property that was identified in SWG-2020-00041 as S003MOA2. The project manager identified this feature as an ephemeral swale lacking an ordinary high water mark.

It does not connect to any tributary or to any of the wetlands delineated and identified as part of that project. The wetland was identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual. They are depressional wetlands with precipitation as the primary source of hydrology.

The nearest known water of the United States (a relatively permanent water {RPW}) is Jayhawker Creek. See attached table for approximate distances of the wetland to Jayhawker Creek. The nearest traditional navigable waterway (TNW) is Caney Creek and it is approximately 15.04 aerial miles away. Based on our review, this wetland does not have surface hydrologic connection to any waters of the U.S.

The wetland is not subject to the ebb and flow of the daily tide, is not currently used, was used in the past, nor is susceptible to use for interstate or foreign commerce.

The wetland does not cross interstate or tribal boundaries.

The destruction of the intrastate wetland would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

The wetland is not an impoundment of any water of the United States.

The wetland is not a tributary nor was it part of a tributary system.

The wetland is not part of the territorial seas.

The wetland is not "adjacent" (per Federal Regulations 33 CFR 328 (b) defines "adjacent" as bordering, neighboring, or contiguous to a water of the US).

The wetland is not a prior converted cropland.

The wetland has been determined to be "isolated" per Federal Regulations. (33 CFR 330.2 (e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States nor adjacent to such tributary waterbodies). Based on the site review and floodplain maps, it was determined that the wetland is located above the anticipated high flow of any waterway (e.g., outside of the 100-year floodplain), does not have a surface hydrologic connection to any tributary, and the wetland has no known nexus to interstate commerce. There are no known species in this georegion that require both the subject wetland and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. As such it is not "ecologically adjacent", as defined in the Rapanos as being "reasonably close" such that an ecologic interconnectivity is beyond speculation and insubstantial; therefore, we determined Wetland 1 is not a water of the United States and is not subject to Section 404 of the Clean Water Act (Section 404) or Section 10 of the Rivers and Harbors Act (Section 10). We also determined that the ditch is not a re-routed tributary, does not extend the ordinary high water mark of any tributary, was constructed out of an isolated wetland and uplands, and does not drain to wetland to any water of the United States. Therefore, the ditch is not a water of the United States and is not subject to Section 404 or Section 10.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
