D1 through D5 are man-made, upland cut, roadside drainage ditches located adjacent to Lauder Road and W. E. Crowley Park Road. All these features display ephemeral flow regimes, as evidenced by the presence of herbaceous vegetation throughout the channels and lack of a consistent source of water. According to the 2008 Rapanos Guidance, ditches excavated in uplands that do not carry a relatively permanent flow of water are not considered jurisdictional under the CWA; therefore, P118 19 00 and D1 through D5 are non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
