2 (0.28 acres), and DD-1 (0.05 acres). OW-1 and OW-2 are open-water features that are excavated wholly in dry land for aesthetic purposes. DD-1 is a concrete lined drainage ditch that is excavated in dry land for the purpose of stormwater run off from the adjacent neighborhood and roads. These are non-tidal waters that have been excavated wholly in dry land that does not transport relatively permanent flow directly or indirectly into a TNW or between two Waters of the U.S. (WOUS). These are best described in the preamble for 33 CFR 328.3, published in the Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), which states “For clarification, it should be noted that we generally do not consider the following waters to be Waters of the United States...(a) Non-tidal drainage or irrigation ditches excavated on dry land....(d) Artificial reflecting or swimming pools or other small ornamental bodies of water created by excavating and/or diking dry land to retain water for primarily aesthetic reasons.”

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
