MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), 1 SWG-2023-00145²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

a. Describe aquatic resources and other features within the review area identified as "generally non-jurisdictional" in the preamble to the 1986 regulations (referred to as "preamble waters"). Ponds, Pond 1 (.28-acres):

Pond 1 is not an impoundment of a water of the United States. Pond 1 is contained wholly within and do not extend beyond the project area boundary. Pond 1 does not have an continuous surface connection to a relatively permanent water. The 1986 preamble to 33 CFR 320-330 regulations states that for clarification it should be noted that we generally do not consider the following waters to be "waters of the United States...(C) Artificial reflecting or swimming pools or other small ornamental bodies of water created by excavating or diking dry land to retain water for primarily aesthetic reasons. Therefore, Pond A is not a water of the United States and is not subject to Section 404 of the Clean Water Act.

- e. Tributaries, Trib 1-2 (1,063 linear feet total):

Based on data sources listed in #9 and our 20 February 2025 desk review, we have determined these tributaries are non-relatively permanent waters. These tributaries do not have a defined bed and bank or a distinguishable ordinary high water mark. The tributaries are the result of the topography within the project area and only flow during heavy precipitation events. Trib 1 flows south into pond 1 within the project boundary. Trib 2 flows south into a pond on the adjacent property outside of the project boundary. The tributaries do not abut or drain any aquatic resources within the project area. The tributaries do not connect to any relatively permanent waters or traditionally navigable waters. Therefore, Tribs 1-2 do not meet the definition of RPW as defined in the pre-2015 regime post Sackett guidance and are not waters of the United States subject to Section 404 of the Clean Water Act.
