Explain: Based on a review of historical topographic maps; historical aerial photographs, USFWS NWI maps, and a field survey conducted on November 8, 2022, fourteen (14) upland-cut roadside drainage ditches (measuring a total of 16,734.59 linear feet) are present within the Project Area, see attached table (**Table 1: Summary of Aquatic Features Delineated within the Project Area**). The Project Area was delineated according to the Atlantic and Gulf Coastal Plain Regional Supplement to the 1987 Corps of Engineers Wetland Delineation Manual. Features D1 through D14 are man-made,

upland-cut roadside drainage ditches that function as stormwater conveyance ditches to drain adjacent developments, including residential neighborhoods. According to the 2008 Rapanos Guidance, ditches (including roadside drainage ditches) excavated in uplands and that do not carry a relatively permanent flow of water are not considered jurisdictional under the CWA; therefore, features D1 through D14 are non-jurisdictional.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The Antecedent Precipitation Tool (APT) was used to evaluate climatic conditions via single point method for the date in which biologists completed the delineation field work on November 8, 2022. A single point method using the latitude and longitude coordinates identified in Section (I) above was utilized because the single point method adequately represents the data sources available via the APT to conduct an appropriate analysis of climatic conditions on-site. According to the APT, conditions within the Project Area were normal relative to the rolling thirty-year period from the field visits conducted on November 8, 2022.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Based on a review of historical topographic maps; historical aerial photographs, USFWS NWI maps, and a field survey conducted on November 8, 2022, fourteen (14) upland-cut roadside drainage ditches (measuring a total of 16,734.59 linear feet) are present within the Project Area, see attached table (Table 1). The Project Area was delineated according to the Atlantic and Gulf Coastal Plain Regional Supplement to the 1987 Corps of Engineers Wetland Delineation Manual. Features D1 through D14 are man-made, upland-cut roadside drainage ditches that function as stormwater conveyance ditches to drain adjacent developments, including residential neighborhoods. According to the 2008 Rapanos Guidance, ditches (including roadside drainage ditches) excavated in uplands and that do not carry a relatively permanent flow of water are not considered jurisdictional under the CWA; therefore, features D1 through D14 are likely non-jurisdictional.
