MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ SWG-2023-00359

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Texas due to litigation.

1. SUMMARY OF CONCLUSIONS.

REVIEW AREA. The project area is an approximate 1,762 linear foot drainage feature that bisects ONEOK's Mont Belvieu Storage (OMBS) and Fractionation Facility. The facility is located at the intersection of Loop 207 and E Winfree Street in Mont Belvieu, Chambers County, Texas. The center coordinates are 29.855956°, -94.891673°.

- 3. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. Cedar Bayou

The unnamed tributary flows into a roadside ditch that connects to culverts that drain south under East Winfree Street. This connection flows south of the project area and into Smith's Gulley. Smith's Gulley flows into Cedar Bayou, a traditional navigable water (TNW).

 - e. Tributaries (a)(5): The aerial photo from 1969 shows the drainage feature already in place. The 1961 topo map shows that the current drainage feature was likely a re-route of the original tributary or drainage system. The drainage feature does not change considerably from 1969-2023. The aerial photos show that the drainage feature has water standing, ponding, or flowing in it more than seasonally. The aerial maps also show that the drainage feature flows into a roadside ditch that connects to culverts that drain south under E Winfree Street.

The aerial and topo maps show that this connection flows south of the project area and into Smith's Gulley. Smith's Gulley flows into Cedar Bayou, a traditional navigable water (TNW). The NWI map also shows that this project drainage connects with Smith's Gulley south of the project area. The google earth aerial photos and the APT show that the drainage feature has relatively permanent flow and the topo maps and the NWI map shows that water from this drainage feature flows indirectly into Cedar Bayou, a TNW. Therefore, the drainage feature (unnamed tributary) is a relatively permanent tributary of Cedar Bayou.
