MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ SWG-2023-00380.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

Based on our 7 November 2023 site visit and desk review, Wetland 1 (0.1-acre), and Wetland 2 (0.1-acre) do not have any known continuous surface connection to the Gulf of Mexico, a TNW located approximately 0.06 miles southeast of the project site, or any other water of the United States. Based on the delineation report and site visit, there are two identified wetlands on the tract. They are located on beach behind a continuous dune, as seen in the most contemporary USGS Topographic map with contours. The dune acts as a barrier and effectively isolates the wetlands from the Gulf of Mexico. No more than overland sheet flow would exit the wetlands. Therefore, Wetland 1 and Wetland 2 do not meet the

definition of adjacent as defined in the pre-2015 regime post Sackett guidance and are not waters of the United States.

- 10. OTHER SUPPORTING INFORMATION. A site visit was conducted on 7 November 2023. The dune system was assessed for continuity and were determined to maintain a height tall enough and continuously to act as a barrier between the wetlands and the Gulf of Mexico. Therefore, the wetlands lack a continuous surface connection and are non-adjacent.
- 11.NOTE: The structure and format of this MFR were developed in coordination with the EPA and Department of the Army. The MFR's structure and format may be subject to future modification or may be rescinded as needed to implement additional guidance from the agencies; however, the approved jurisdictional determination described herein is a final agency action.


