#### MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), 1 SWG-2024-00044, MFR 1 of 1.2

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

  - The project area contains one ditch, D-1. D-1 has a defined bed and bank and ordinary high-water mark. The ditch was constructed from uplands between 2014 and 2015 according to Google Earth aerials. Google Earth aerials 2019, 2021, 2022, and 2023 do not show any significant flow in the ditch. Climactic conditions at the time of the aerial were Drier than Normal in 2019, Normal in 2021 and 2022, and Wetter than Normal in 2023. The ditch exhibits low volume, infrequent, and/or short duration flow indicating that the ditch's primary source of water is runoff from rainfall. D-1 is not a relatively permanent water and does not meet the definition of a tributary as defined in the pre-2015 regime post Sackett guidance and is not a water of the United States.
- c. Describe aquatic resources and features identified within the review area as waste treatment systems, including treatment ponds or lagoons designed to meet the requirements of CWA. - d. Describe aquatic resources and features within the review area determined to be prior converted cropland in accordance with the 1993 regulations (reference 2.b.). One pond was identified, P-1, totaling 1.03 acre. This pond was constructed out of uplands between 2022 and 2023 according to Google Earth aerials. The use, degradation, or destruction of P-1 would not affect interstate or foreign commerce. The pond is not used for interstate or foreign travelers for recreational or other purposes, fish or shellfish are not taken and sold in interstate or foreign commerce and are not used for industrial purpose by industries in interstate commerce. The pond is not an impoundment of a tributary and does not flow to a Traditional Navigable Water, therefore, the pond is not a water of the United States.
