MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ SWG-2024-00084, MFR 1 of 1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States,'" as

amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

1. SUMMARY OF CONCLUSIONS.

- a. The 52.4-acre review area contains the Boeye Reservoir, an Excavated, Lacustrine Limnetic water feature with an unconsolidated bottom, that is permanently flooded. The Boeye Reservoir was excavated from uplands to act as a water storage reservoir and settling basin for the City of McAllen's water treatment system.

3. REVIEW AREA. The 52.4-acre review area consists entirely of the Boeye Reservoir, excavated from uplands to act as a water storage reservoir and settling basin for the City of McAllen's water treatment system.

The 52.4-acre Boeye Reservoir was excavated from uplands to act as a water storage reservoir and settling basin for the City of McAllen’s water treatment system. There is no continuous surface connection from Boeye Reservoir to any relatively permanent water. This feature is best described in the preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published 13 NOV 1986 (page 41217), which states, “For clarification, it should be noted that we generally do not consider the following waters to be Waters of the United States (c) Artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing.”.
