MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), 1 SWG-2024-00418²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

- 3. REVIEW AREA. An approximate 18.07-acre tract is located between the intersections of Thunder Road and Canal Drive to Thunder Road and the intersection of Militia Drive, 28.944889 N, -95.301109 W, Surfside, Galveston County, Texas
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. Gulf Intercoastal Waterway (GIWW) and the Freeport Jetty Entrance.
- 5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS. The Wetlands (approx. 18.07 acres) identified in the review area are part of one continuous wetland complex which abuts and is adjacent to the GIWW and the Freeport Jetty Entrance. RPW 1 (940 linear feet) and RPW 2 (653 linear feet) extend the tidal waters of the GIWW via a series of culverts into the review area and the wetlands identified in the review area abut RPW 1 and RPW 2.
- 6. SECTION 10 JURISDICTIONAL WATERS⁶: Describe aquatic resources or other features within the review area determined to be jurisdictional in accordance with Section 10 of the Rivers and Harbors Act of 1899. - a. TNWs (a)(1): Freeport Entrance Channel (0.02 acre) is an extension of the GIWW, a traditional navigable waterway. Therefore, the Freeport Entrance Channel is subject to Section 10 of the Rivers and Harbors Act and Section 404 of the Clean Water Act.

- d. Impoundments (a)(4): N/A
- e. Tributaries (a)(5): RPW-1 & RPW-2 are roadside/tidally influenced ditches with permanent flow which connects via several culverts to the GIWW, a TNW, and the Freeport Entrance Channel, a TNW. RPW-1 and RPW-2 meet the definition of a tributary as defined in the pre-2015 regime post Sackett guidance and are waters of the United States.
- f. The territorial seas (a)(6): N/A
- g. Adjacent wetlands (a)(7): Wetlands (~ 18.07 acres) identified in the review area are subject to the ebb and flow of the daily tide and/or abut tidal RPWs that directly flow into a TNW. These wetlands abut relatively permanent waters (RPW-1 & RPW-2) and traditional navigable waters (GIWW & Freeport Channel Entrance); therefore, these wetlands meet the definition of adjacent as defined in the pre-2015 regime post Sackett guidance and are waters of the United States.
