#### MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), <sup>1</sup> SWG-2025-00473<sup>2</sup>

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

3. REVIEW AREA. The 20-acre review area is located at 801 Graham Road within the Flour Bluff area of Corpus Christi, Nueces County, Texas. It is bordered to the north by Graham Road and to the south, east, and west by residential properties.

**Excavated Pond (WB 102A):** LiDAR, topos, aerial photographs, and the applicant-provided plans were utilized as part of the desktop analysis to identify that this water feature is a borrow area for fill material that has been excavated from uplands. This excavated pond does not have any continuous surface connection to a RPW or TNW. This feature is best described in the preamble for 33 CFR 328.3, published in the Federal Register Volume 51, Number 219, November 13, 1986 (page 41217), which states "For clarification, it should be noted that we generally do not consider the following waters to be Waters of the United States...(e) "waterfilled depressions created in dry land incidental to construction activities and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the operation is abandoned and the resulting body of water meets the definition of waters of the United States." This pond was created in uplands for the purpose of obtaining fill material and is not a water of the United States.

WB 102 A extends outside the review area boundary. However, due to a rise in elevation surrounding its location, this waterbody does not have any continuous surface connection with an RPW or TNW.

**Excavated Pond (WB 102 B):** LiDAR, topos, aerial photographs, and the applicant-provided plans were utilized as part of the desktop analysis to identify that this water feature is a borrow area for fill material that has been excavated from uplands. This excavated pond does not have any continuous surface connection to a RPW or TNW. This feature is best described in the preamble for 33 CFR 328.3, published in the Federal Register Volume 51, Number 219, November 13, 1986 (page 41217), which states "For clarification, it should be noted that we generally do not consider the following waters to be Waters of the United States...(e) "waterfilled depressions created in dry land incidental to construction activities and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the operation is abandoned and the resulting body of water meets the definition of waters of the United States." This pond was created in uplands for the purpose of obtaining fill material and is not a water of the United Sates.

  - **Wetlands 101 PEM, 102 PEM:** LiDAR, topo, aerial photographs, the applicant-provided delineation report, and a site visit were utilized as part of the desktop analysis to identify that these palustrine wetlands reside in small depressional areas entirely with the review area that collect rainwater from the surrounding countryside. There is no presence of any swales, erosional features, ditches, or culverts that would potentially serve as surface connections. There is no presence of a continuous surface connection, with no more than overland sheet flow exiting from these wetlands to an RPW or TNW. These wetlands do not meet the definition of adjacent as defined in the pre-2015 regime post Sackett guidance and are not waters of the United States.




