MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ SWG-2025-00627

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

3. REVIEW AREA. The review area is a 55-acre tract of land between West Fuqua Street and Sam Houston Tollway, 0.42-mile west of Almeda Road, in Houston, Harris County, Texas.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The nearest TNW is Sims Bayou. Harris County Flood Control District (HCFCD) Channel C143-00-00, within the review area, extends 0.4 miles north of the project boundary and connects/flows into Sims Bayou. TNW.⁵

- e. Tributaries (a)(5): In photos provided by the applicant, HCFCD Channel C143-00-00 shows an Ordinary High-Water Mark (OHWM), a bed, and bank. There is staining on the outfall wingwalls, riprap, and vegetation showing the water levels in the channel is routinely higher for long periods of time. There is standing/flowing water in all photos throughout the channel since before 1975. Therefore, the channel is an RPW tributary that flows into Sims Bayou, a TWN, and is therefore jurisdictional.

based solely on the “Migratory Bird Rule.” Include the size of the aquatic resource or feature, and how it was determined to be an “isolated water” in accordance with SWANCC. N/A

- f.  - Wetland PFO1A drains into an unnamed ditch that does not have relatively permeant flow and is located outside of the review area. This unnamed ditch does not connect to a RPW, TNW, or any other aquatic resource. Wetland PFO1A does not have a continuous surface connection to a RWP or TNW and is considered non-jurisdictional.
 - Wetland PEM1C does not have continuous surface connection to any aquatic resource and is separated by uplands; therefore, PEM1C is considered non-jurisdictional.

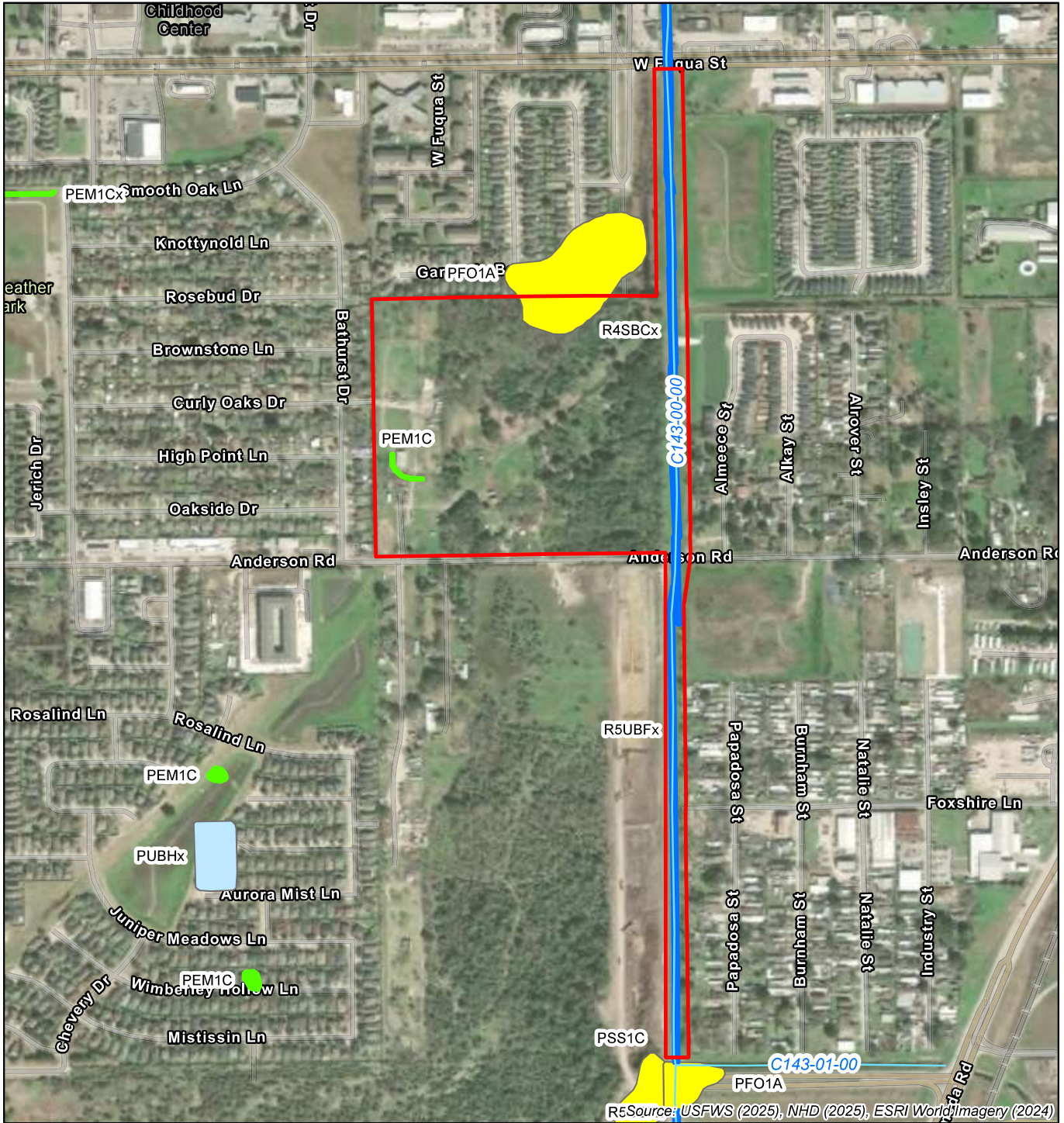

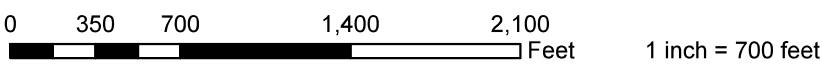
