C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Texas. This project area contained 2 primary identified isolated wetlands totaling less than 5.5 acres: (Wet 1 is appx. 0.02-acre, Wet 2 less than 5.5-acre). This area has historically been highly manipulated as illustrated in the aeriels and USGS maps. In the 1920 Spring, TX topo map, the area appeared to have a headwater to a tributary ultimately routed to Cypress Creek originating just south of the property boundary. In the 1977 Aerial, the south central portion of the site had excavation activities, creating a borrow pit. Between 1995 and 2001 the aerial photographs indicated the site was land leveled and the borrow pit had been completely filled. The site visit conducted on 26 March 2015 by Corps staff (after above normal precipitation events) revealed there is no natural spring or associated tributary (i.e. head water type features) on the site. The 2013 topo inaccurately depicts a small open body of water, but this is not an accurate representation of current conditions as no pond remains within the project area.

In conclusion, this site has some wetlands present but the site is highly disturbed and altered with numerous types of excavation, fill and plowing activities. There is a drainage ditch constructed on the site in the northeast corner that connects to the roadside ditch.

The closest waterbody is Cypress Creek (a TNW at this point) located south of the site approximately 1.75 miles away.

These wetlands (Wet 1 & 2) have been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which requires that, under normal circumstances, an area has predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support an aquatic ecosystem. These isolated wetlands are located in a depressional landscape position. The principal source of hydrology is precipitation.

The two wetlands areas are located outside the 100-year floodplain of any waterway; thus these wetlands lay beyond any anticipated high flow of any water (and are not inseparably bound with any water of the U.S.) The wetlands are not "ecologically adjacent" as there are not any known biological species in this geo-region that require the wetlands and the nearest waterway (including TNW) for completion of their lifecycle requirements.

Isolated waters are defined in federal Regulations 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable water of the United States; and (2) Not adjacent to such tributary water bodies. There are no confined surface hydrologic connections between these wetlands and any potential or known water of the U.S.

In conclusion: Using off-site and on-site review of these two wetlands (Wet 1 & 2) are isolated and are not currently used, were not used in the past, nor are they susceptible to use in interstate or foreign commerce. They are not subject to the ebb and flow of the daily tide, nor are they part of a territorial sea. They do not cross interstate or tribal boundaries. Wet 1 & 2 do not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce. These wetlands are not impoundments of waters of the United States. Wet 1 & 2 are not part of a surface tributary system. These wetlands are not adjacent to any other waters previously identified.

Wet 1 & 2 have been determined by the Galveston District to be isolated (as defined in federal regulation 33CFR 330.2(e)). They are located outside the anticipated high flow of any water of the United States and do not have a confined hydrological surface connection to any water of the United States and are not "inseparably bound" to any waters of the United States under normal hydrologic conditions. Therefore, it is our determination that these are isolated (as per federal regulation) wetlands and do not possess any known nexus to interstate commerce. They are not subject to federal regulation under Section 404 of the Clean Water Act

B. ADDITIONAL COMMENTS TO SUPPORT JD:

There are two identified wetlands on the project site totaling less than 5.5 acres. The project area is located southwest of the intersection of Spring Cypress Road and Kuykendahl Road in the City of Spring, Harris County, Texas. This project area contained 2 primary identified

isolated wetlands totaling less than 5.5 acres: (Wet 1 is appx. 0.02-acre, Wet 2 less than 5.5-acre). This area has historically been highly manipulated as illustrated in the aeriels and USGS maps. In the 1920 Spring, TX topo map, the area appeared to have a headwater to a tributary ultimately routed to Cypress Creek originating just south of the property boundary. In the 1977 Aerial, the south central portion of the site had excavation activities, creating a borrow pit. Between 1995 and 2001 the aerial photographs indicated the site was land leveled and the borrow pit had been completely filled. The site visit conducted on 26 March 2015 by Corps staff (after above normal precipitation events) revealed there is no natural spring or associated tributary (i.e. head water type features) on the site. The 2013 topo inaccurately depicts a small open body of water, but this is not an accurate representation of current conditions as no pond remains within the project area. In conclusion, this site has some wetlands present but the site is highly disturbed and altered with numerous types of excavation, fill and plowing activities. There is a drainage ditch constructed on the site in the northeast corner that connects to the roadside ditch.

The closest waterbody is Cypress Creek (a TNW at this point) located south of the site approximately 1.75 miles away.

These wetlands (Wet 1 & 2) have been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which requires that, under normal circumstances, an area has predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support an aquatic ecosystem. These isolated wetlands are located in a depressional landscape position. The principal source of hydrology is precipitation.

The two wetlands areas are located outside the 100-year floodplain of any waterway; thus these wetlands lay beyond any anticipated high flow of any water (and are not inseparably bound with any water of the U.S.) The wetlands are not "ecologically adjacent" as there are not any known biological species in this geo-region that require the wetlands and the nearest waterway (including TNW) for completion of their lifecycle requirements.

Isolated waters are defined in federal Regulations 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable water of the United States; and (2) Not adjacent to such tributary water bodies. There are no confined surface hydrologic connections between these wetlands and any potential or known water of the U.S.

In conclusion: Using off-site and on-site review of these two wetlands (Wet 1 & 2) are isolated and are not currently used, were not used in the past, nor are they susceptible to use in interstate or foreign commerce. They are not subject to the ebb and flow of the daily tide, nor are they part of a territorial sea. They do not cross interstate or tribal boundaries. Wet 1 & 2 do not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce. These wetlands are not impoundments of waters of the United States. Wet 1 & 2 are not part of a surface tributary system. These wetlands are not adjacent to any other waters previously identified. Wet 1 & 2 have been determined by the Galveston District to be isolated (as defined in federal regulation 33CFR 330.2(e)). They are located outside the anticipated high flow of any water of the United States and do not have a confined hydrological surface connection to any water of the United States and are not "inseparably bound" to any waters of the United States under normal hydrologic conditions. Therefore, it is our determination that these are isolated (as per federal regulation) wetlands and do not possess any known nexus to interstate commerce. They are not subject to federal regulation under Section 404 of the Clean Water Act

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
