U.S. ARMY CORPS OF ENGINEERS, GALVESTON DISTRICT

PURPOSE OF PUBLIC NOTICE: To inform you of a proposed Regional and Programmatic General Permit (GP) for work in which you might be interested. It is also to solicit your comments and information to better enable us to make a reasonable decision on factors affecting the public interest.

AUTHORITY: This application will be reviewed pursuant to Section 10 of the Rivers and Harbors Act of 1899.

APPLICANT: U.S. Army Corps of Engineers, Galveston District

LOCATION: The GP will be valid within navigable waters of the U.S. within the SWG boundaries, excluding waters located in Louisiana and the Gulf of America.

PROJECT DESCRIPTION: This GP authorizes structures and work in navigable waters of the U.S. for the construction, repair, rehabilitation, maintenance, modification, and replacement of a single, pile-supported pier at single-family properties, multi-family properties, or at lodging facilities.

AVOIDANCE AND MINIMIZATION: The general permit is conditioned to result in no more the minimal impacts.

MITIGATION: The GP does not authorize permanent loss of special aquatic sites and does not require compensatory mitigation.

current conditions: This GP serves as both a regional and programmatic general permit. The GP allows the Texas General Land Office (TXGLO) to administer the subject permitting on state-owned submerged lands in Texas. The TXGLO has responsibility and authority to execute and perform all acts and other things related to public real property of the state or right of individuals in pub-lic real property, which is required by law, and requires lease agreements for structures on State-owned lands. As such, the Corps and TXGLO developed a programmatic agreement for the GP to streamline the permit evaluation process and avoid unneces-sary duplication of federal and state permit requirements. The Corps evaluates GPs in areas not under TXGLO jurisdiction.

The Corps evaluates an average of 17 GPs and the TXGLO evaluates an average of 42 GPs annually. While these 59 actions annually may include repair, rehabilitation, and maintenance activities; the majority of actions are construction and modification of pier and boathouse combinations.

A preliminary review of this GP indicates that an Environmental Impact Statement (EIS) is not required. Since assessment is a continuing process, this preliminary determination of EIS requirement will be changed if data or information brought forth in the coordination process is of a significant nature.

OTHER AGENCY AUTHORIZATIONS:

The GP is conditioned to be consistent with the Texas Coastal Management Program (CMP) goals and policies and will be conducted in a manner consistent with said Program. The TXGLO will determine if the GP is consistent with the goals and policies of the CMP.

No water quality certification is required.

NATIONAL REGISTER OF HISTORIC PLACES: The GP requires pre-construction notification. During this review, the staff archaeologist will review the latest published version of the National Register of Historic Places, lists of properties determined eligible, and other sources of information and make a determination on presence or absence of historic properties and the effects of the undertaking upon these properties.

THREATENED AND ENDANGERED SPECIES: Threatened and/or endangered species and their critical habitat may be affected by the proposed work. Consultation with the U.S. Fish and Wildlife and the National Marine Fisheries Service has been initiated to assess the effect on endangered species.

ESSENTIAL FISH HABITAT: This notice initiates the Essential Fish Habitat consultation requirements of the Magnuson-Stevens Fishery Conservation and Management Act. The proposed GP may affect species listed in the Gulf of Mexico Fishery Management Plans including: red drum, triggerfishes (*Balistidae*), jacks (*Carangidae*), wrasses (*Labridae*), snappers (*Lutjanidae*), tilefishes (*Malacanthidae*), groupers (*Serranidae*), and coastal migratory pelagic species, shrimps, stone crabs, and spiny lobsters.

Impacts may include temporary increases in turbidity and sediment plumes during piling installation. These impacts may reduce light penetration, clog fish gills and potentially release contaminates trapped in sediments. On average approximately 7 piles are installed daily and piling installation generall occurs from 1-3 months.

The GP is conditioned to prohibit the permanant loss of special aquatic sites such as weltands and seagrasses. Impacts to these resources are further miminized by required heights above the waterline and spacing in-between deck boards to limit permanent shading.

Our initial determination is that the GP would not have a substantial adverse impact on Essential Fish Habitat or federally managed fisheries in the Gulf of America. Our final determination relative to project impacts and the need for mitigation measures is subject to review by and coordination with the National Marine Fisheries Service.

PUBLIC INTEREST REVIEW FACTORS: This application will be reviewed in accordance with 33 CFR 320-332, the Regulatory Programs of the Corps, and other pertinent laws, regulations and executive orders. The decision whether to issue a permit will be based on an evaluation of the probable impacts, including cumulative impacts, of the proposed activity on the public interest. That decision will reflect the national concern for both protection and utilization of important resources. The benefits, which reasonably may be expected to accrue from the proposal, must be balanced against its reasonably foreseeable detriments. All factors, which may be relevant to the proposal, will be conservation, considered: among those are economics, general environmental concerns, wetlands, historic properties, fish and wildlife values, flood hazards, floodplain values, land use, navigation, shore erosion and accretion, recreation, water supply and conservation, water quality, energy needs, safety, food and fiber production, mineral needs and, in general, the needs and welfare of the people.

SOLICITATION OF COMMENTS: The Corps is soliciting comments from the public, Federal, State, and local agencies and officials, Indian tribes, and other interested parties in order to consider and evaluate the impacts of this proposed activity. Any comments received will be considered by the Corps to determine whether to issue, modify, condition or deny a permit for this proposal. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects, and the other public interest factors listed above. Comments are used in the preparation of an Environmental Impact Assessment and/or an EIS pursuant to the National Environmental Policy Act. Comments are also used to determine the need for a public hearing and to determine the overall public interest of the proposed activity.

This public notice is being distributed to all known interested persons in order to assist in developing facts upon which a decision by the Corps may be based. For accuracy and completeness of the record, all data in support of or in opposition to the proposed work should be submitted in writing setting forth sufficient detail to furnish a clear understanding of the reasons for support or opposition.

PUBLIC HEARING: The purpose of a public hearing is to solicit additional information to assist in the evaluation of the proposed project. Prior to the close of the comment period, any person may make a written request for a public hearing, setting forth the particular reasons for the request. The District Engineer will determine if the reasons identified for holding a public hearing are sufficient to warrant that a public hearing be held. If a public hearing is warranted, all known interested persons will be notified of the time, date, and location.

CLOSE OF COMMENT PERIOD: All comments pertaining to this public notice must reach this office on or before 20 August 2025. Extensions of the comment period may be granted for valid reasons provided a written request is received by the limiting date. If no comments are received by that date, it will be considered that there are no objections.
