U.S. ARMY CORPS OF ENGINEERS, GALVESTON DISTRICT AND TEXAS COMMISSION ON ENVIRONMENTAL QUALITY

PURPOSE OF PUBLIC NOTICE: To inform you of a proposal for work in which you might be interested. It is also to solicit your comments and information to better enable us to make a reasonable decision on factors affecting the public interest. The U.S. Army Corps of Engineers (Corps) is not the entity proposing or performing the proposed work, nor has the Corps taken a position, in favor or against the proposed work.

AUTHORITY: This application will be reviewed pursuant to Section 404 of the Clean Water Act (CWA).

LOCATION: The project site is located adjacent to Harper's Horse Pen, in Shenandoah, Montgomery County, Texas. The project can be located on the U.S.G.S. quadrangle map titled: Tamina, Texas.

LATITUDE & LONGITUDE (NAD 83):

Latitude: 30.202818° North; **Longitude:** 095.448672° West

PROJECT DESCRIPTION: The applicant is proposing to permanently discharge fill material into 2.33 acres of palustrine forested wetlands for the new construction of a 1,950-foot-long four-lane roadway that will include curbs, culverts, storm sewer drains, and other necessary infrastructure known as the *David Memorial Roadway Extension*. The proposed work area, or right-of-way (ROW) will be approximately 100-foot-wide. The proposed construction will also include temporary impacts to 2.15 acres of palustrine forested wetlands. Once work has ceased, the temporarily impacted areas will be restored back to natural contours and elevations for the natural revegetation of the work area.

AVOIDANCE AND MINIMIZATION: The applicant has stated that they have avoided and minimized the environmental impacts by designing the roadway to not impact Harpers Horseshoe Branch, a perennial stream. The applicant has also kept the ROW to the minimum necessary to achieve the purpose and need. Additionally, the applicant will also implement culverts under the road to allow for water passage maintaining the natural hydrology of the site while preventing impounding on either side of the elevated road.

MITIGATION: The applicant proposed to mitigate for the proposed impacts by debiting 10.47 FCUs from the Tarkington Bayou Mitigation Bank.

CURRENT SITE CONDITIONS: The proposed David Memorial Roadway Extension Project is located on an approximately 4.48-acre parcel in City of Conroe ETJ, in Montgomery County, Texas. The study area is generally located east of I-45 and between the present-day termini of David Memorial Drive between the MetroPark Square development to the south and the Methodist Hospital to the north. The study area appears to be located in the West Fork San Jacinto 8-digit Hydrologic Unit Code (HUC) watershed (12040101).

Based on historic aerial imagery and current observations, most of the site appears to have been undeveloped. Palustrine forested wetlands comprises 100% of the study area and is dominated by wetland vegetation such as, but not limited to, Chinese tallow (*Triadica sebifera*), Green Ash (*Fraxinus pennsylvanica*) and Black Willow (*Salix nigra*). According to the USDA Texas Soil Survey for Montgomery County, mapped soil types within the study area include: Bissonet loam, 0 to 1 percent slopes (BisA) and Sorter-Tarkington complex, 0 to 1 percent slopes (SosA). Neither of these mapped soil types are located on the Montgomery County hydric soils list; however, hydric soils were identified within the study area. According to the USGS topographic map the study area is located within and surrounded by a marsh area. One "blue-line" feature is depicted to the west of the study area on the topographic map. According to the FEMA flood hazard map, the study area is located within the mapped 100-year floodplain (Zone AE). The southern portion of the study area is depicted within the designated floodway.

NOTES: This public notice is being issued based on information furnished by the applicant. This project information has not been verified by the Corps. The applicant's plans are enclosed in 14 sheets.

A preliminary review of this application indicates that an Environmental Impact Statement (EIS) is not required. Since permit assessment is a continuing process, this preliminary determination of EIS requirement will be changed if data or information brought forth in the coordination process is of a significant nature.

Our evaluation will also follow the guidelines published by the U.S. Environmental Protection Agency pursuant to Section 404 (b)(1) of the CWA.

OTHER AGENCY AUTHORIZATIONS: This project would result in a direct impact of greater than three acres of waters of the state or 1,500 linear feet of streams (or a combination of the two is above the threshold), and as such would not fulfill Tier I criteria Therefore, Texas Commission on Environmental Quality (TCEQ) for the project. certification is required. Concurrent with Corps processing of this application, the TCEQ is reviewing this application under Section 401 of the CWA and in accordance with Title 30, Texas Administrative Code Section 279.1-13 to determine if the work would comply with State water quality standards. By virtue of an agreement between the Corps and the TCEQ, this public notice is also issued for the purpose of advising all known interested persons that there is pending before the TCEQ a decision on water quality certification under such act. Any comments concerning this application may be submitted to the Texas Commission on Environmental Quality, 401 Coordinator, MSC-150, P.O. Box 13087, Austin, Texas 78711-3087. The public comment period extends 30 days from the date of publication of this notice. A copy of the public notice with a description of work is made available for review in the TCEQ's Austin office. The complete application may be reviewed in the Corps office listed in this public notice. The TCEQ may conduct a public meeting to consider all comments concerning water quality if requested in writing. A request for a public meeting must contain the following information: the name, mailing address, application number, or other recognizable reference to the application; a brief description of the interest of the requester, or of persons represented by the requester; and a brief description of how the application, if granted, would adversely affect such interest.

NATIONAL REGISTER OF HISTORIC PLACES: The staff archaeologist has reviewed the latest published version of the National Register of Historic Places, lists of properties determined eligible, and other sources of information. The following is current knowledge of the presence or absence of historic properties and the effects of the undertaking upon these properties:

"The permit area is likely to contain terrestrial cultural resources that could be eligible for inclusion in the National Register of Historic Places. The applicant will need to conduct an investigation for historic properties."

THREATENED AND ENDANGERED SPECIES: Preliminary indications are that no known threatened and/or endangered species or their critical habitat will be affected by the proposed work.

PUBLIC INTEREST REVIEW FACTORS: This application will be reviewed in accordance with 33 CFR 320-332, the Regulatory Programs of the Corps, and other pertinent laws, regulations and executive orders. The decision whether to issue a permit will be based on an evaluation of the probable impacts, including cumulative impacts, of the proposed activity on the public interest. That decision will reflect the national concern for both protection and utilization of important resources. The benefits, which reasonably may be expected to accrue from the proposal, must be balanced against its reasonably foreseeable detriments. All factors, which may be relevant to the proposal, will be considered: among those are conservation, economics, general environmental concerns, wetlands, historic properties, fish and wildlife values, flood hazards, floodplain values, land use, navigation, shore erosion and accretion, recreation, water supply and conservation, water quality, energy needs, safety, food and fiber production, mineral needs and, in general, the needs and welfare of the people.

SOLICITATION OF COMMENTS: The Corps is soliciting comments from the public, Federal, State, and local agencies and officials, Indian tribes, and other interested parties in order to consider and evaluate the impacts of this proposed activity. Any comments received will be considered by the Corps to determine whether to issue, modify, condition or deny a permit for this proposal. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects, and the other public interest factors listed above. Comments are used in the preparation of an Environmental Impact Assessment and/or an EIS pursuant to the National Environmental Policy Act. Comments are also used to determine the need for a public hearing and to determine the overall public interest of the proposed activity.

This public notice is being distributed to all known interested persons in order to assist in developing facts upon which a decision by the Corps may be based. For accuracy and completeness of the record, all data in support of or in opposition to the proposed work should be submitted in writing setting forth sufficient detail to furnish a clear understanding of the reasons for support or opposition.

PUBLIC HEARING: The purpose of a public hearing is to solicit additional information to assist in the evaluation of the proposed project. Prior to the close of the comment period, any person may make a written request for a public hearing, setting forth the particular reasons for the request. The District Engineer will determine if the reasons identified for holding a public hearing are sufficient to warrant that a public hearing be held. If a public hearing is warranted, all known interested persons will be notified of the time, date, and location.

CLOSE OF COMMENT PERIOD: All comments pertaining to this public notice must reach this office on or before **4 October 2021**. Extensions of the comment period may be granted for valid reasons provided a written request is received by the limiting date. **If no comments are received by that date, it will be considered that there are no objections**.
