C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Nueces River is (1) listed on the Galveston District List of Navigable Waters (Section 10 List), (2) is subject to the ebb and flow of the tide, and (3) is presently used, has been used in the past, or may be susceptible for use to transport interstate or foreign commerce. Per the Rapanos Guidance, all Section 10 waters are traditionally navigable waters (TNW) and subject to Section 404 of the CWA. The wetland is located within the anticipated high flooding zone (ie. 100-yr floodplain) of the Nueces River, and exhibits all three mandatory wetland criteria. Since it is located within the floodplain terrace of the Nueces River, per 33CFR328.3, it is considered adjacent to the TNW.
